Subject: Item No. 3 – Community Outreach Plan Update

On April 7, 2015, the Anaheim City Council approved Resolution No. 2015-147 providing that public input and access to community meetings is encouraged.

The city values our community's input and recognizes that public attendance and participation at district meetings is instrumental in shaping Anaheim's future. Staff has therefore developed a comprehensive outreach plan to present opportunities for the greatest level of transparency and public participation.

Optimal outreach can be achieved through partnership, collaboration, and community investment. A number of efforts have already occurred and continue to take place prior to and following each meeting. As a result, the Committee's kick-off meeting and second meeting were well attended; however greater participation by the community is encouraged and outreach continues. Efforts taken and underway include: Press releases, e-info notifications, Facebook, Twitter, e-postcard to identified community leaders and groups, Fast Facts Flyer (printed and placed in all city facilities, libraries, community centers, distributed by community members/groups, and handed out by internal staff in the field), articles in the Anaheim Magazine, Public Utility Newsletter, and Andy Anaheim; utility bill insert, distribution of information at the Save Water Expo (June 6), meeting information provided to the City's Chief's Advisory Board and Chief's Neighborhood Advisory Council, which represents 22 neighborhoods throughout the city, a Public Service Announcement to be aired on the city's local channel, YouTube, webpage and other media outlets, and possible media interviews in print and radio. Resource information is also available on the dedicated districting webpage (www.anaheim.net/districts) and can be translated into various languages.

Subject: Item No. 4 – Scheduling of Committee Meetings

City Council Resolution No. 2015-147 provides that the Advisory Committee on Electoral Districts (Committee) will meet an average of twice per month and file a written report to the City Council by October 6, 2015, recommending one or more district maps. As such, if the Committee wishes to schedule additional meeting dates at this time, staff recommends the Committee set meeting dates and direct staff to identify meeting locations, based on availability. Staff will return to the committee for final approval of remote locations, including the City Council Chambers.

The attached calendar highlights the currently scheduled meeting dates and various locations, all commencing at 6:30 p.m. A map depicting the current meeting locations is also attached.

In addition to the scheduled meetings, city staff will attend the regularly scheduled Neighborhood Council Meetings on July 15 (West District), July 16 (East District), July 22 (Central District), and July (South District), beginning at 7:00 p.m. In our continual effort towards education, public engagement and participation about the districting process, staff intends to share draft maps during these neighborhood meetings and answer questions.

All offsite Committee meetings will be audio-taped and made available on the Districting webpage. Spanish interpretation services will be available, with other languages available upon request. Outreach to inform the communities in these areas, as well as throughout Anaheim, will continue to ensure interested residents are made aware of the meetings and encouraged to attend and participate.


